**Auctioning “sale” of scrapped Vehicles “Taxis” and the Establishment &
Operation of Vehicles Recycling Plant, according to the following:**

- Initial quantity of scrapped vehicles to be auctioned is 15,305 unit (non -registerable) to be increased by an average of approx. 2000 units every month (Estimated) , under the condition of establishing and operating a vehicle recycling plant/centre. Contract base period is five (5) years with Five (5) additional option years (contract extension of a similar period)
- Auction Terms and Condition document (in Arabic only) is available for purchase upon request from the General Authority for Governmental Services located at 7, Dr. Mohamed Hamed Fahmy Street, Dokki, Giza, Egypt. Purchase value of the document is Five Hundred (500) Egyptian Pounds
- Inspection of scrapped vehicles (Taxis) stored at designated yard located at KM 10.5 Cairo- Alex desert road is scheduled for the period of 28/12/2009 - 31/1/2010 between 9:00 am and 3:00 pm.
- Bidders' questions and answers session is scheduled on 11/1/2010 at the Ministry of Finance Towers (Head Quarter) 15th floor, Ramsis Street Extension, Abasia, Cairo Egypt. This session is restricted to those who have purchased the Auction Terms and Condition Document.
- Bids must be submitted in two separate envelopes, one for technical proposal, and the other for the financial. Bids shall be submitted to the designated person chairing this procurement committee at the Ministry of Finance Towers, 15th floor, Ramsis Street Extension, Abasia, Cairo Egypt.
- Bids' submission and opening of technical envelopes session is 12:00 noon on 1/2/2010
- Auction bond for the value of Hundred Thousand (LE100,000) Egyptian Pound for the scrapped Vehicles Purchase scope must be submitted with the bid
- Bids that are submitted after the aforementioned deadline, and those submitted without the bonds mentioned in the bidding document will be rejected.
- The Auction Session will be held on Monday, 15/2/2010 at 12:00 noon, at the Ministry of Finance Towers, 15th floor, Ramsis Street Extension, Abasia, Cairo Egypt.
- Auctioning open price will start at the highest submitted bid per vehicle, and the auction will be awarded to the highest price reached by the end of the auction session.
